Important information about OYS Portfolios

OYS Portfolios is a service developed by InstaForex. Based on the ForexCopy mechanism, it allows traders to copy Portfolios.

OYS Portfolios are trading accounts comprised of the asset or group of assets that are managed by the Company's specialists.

The OYS Portfolios service is aimed at helping investors select the most suitable portfolios that comply with the customers' risk attitude.

The OYS Portfolios are passive investments, which implies an investing strategy that tracks a market-weighted instrument (like index) or portfolio of instruments (equities) representing specific segments of the financial market, or tracking prices of specific instruments.







Investment Objective

The Portfolio OYS Bitcoin CFD (¾) employs an investment approach designed to track the performance of the NYSE Bitcoin Index (NYXBT). NYXBT is a price index that tracks the price of Bitcoin. Bitcoin is the largest digital cryptocurrency by market capitalization.

Assets

CFDs on Bitcoin and Cash.

The Portfolio OYS Bitcoin CFD (¾) invests approximately 2/3 of investment capital in CFDs (contract for difference) on Bitcoin, whereas the rest of investment capital (1/3) is kept in cash for supporting margin positions.







Fees and Expenses

The following table describes the fees and expenses you may pay if you copy the Portfolio OYS Bitcoin CFD (3/3)



Profit fee

The fees that are paid to the Company for profitable opened positions or/and profitable closed positions from your investments. Profit fee is charged on a quarterly basis on gained profit ONLY and at the moment when positions are liquidated (closed).

The charged quarterly fees may reduce profit or even cause losses, in which case no fees are charged on realized profit (the profit when all positions are closed).

Trading expenses

Market fees such as spreads and swaps. Actual spreads and swaps values are indicated on the page www.instaforex.eu/specifications for OYS account type. The company doesn't charge any markups on these fees (liquidity providers' raw spreads and swaps are used only).



Example

The following example is intended to help you compare the cost of copying the Portfolio OYS Bitcoin CFD ($\frac{2}{3}$) with the cost of investing in other similar products. It illustrates the hypothetical expenses that you would incur over various periods if you were to invest \$100,000 in copying the Portfolio OYS Bitcoin CFD ($\frac{2}{3}$). This example assumes that holding positions as it is presented on the managed Portfolio OYS Bitcoin CFD ($\frac{2}{3}$) provides various performance scenarios and that total operating expenses remain as stated in the preceding table. You would incur these hypothetical expenses whether or not you were to close your positions at the end of the given period. Although your actual costs may be higher or lower, based on these assumptions your costs would be:

Principal Risks

An investment in Bitcoin through the Portfolio OYS Bitcoin CFD ($\frac{3}{3}$) could cause losses over short or long periods. You should know that the Bitcoin CFD asset that composes the 2/3 of the Portfolio OYS Bitcoin CFD ($\frac{3}{3}$) is subject to extra high fluctuations within a short and wide range. For example, the 52-Week Range is 4,106.98-47,982.53 USD or 1,068.32% (on 12.02.2021). The Portfolio OYS Bitcoin CFD ($\frac{3}{3}$) is subject to the following risks which could affect the Portfolio's performance:



Technology Reliance:

Bitcoin is a digital currency that is fully reliant on technology. Coins are digitally mined, exchanged via smart wallet and kept in check using various systems. Unlike other currencies or investments, there is no physical collateral to back it up. With gold, real estate, bonds or mutual funds, you own something that can be exchanged. With a currency that is 100% technology-based, bitcoin owners are more vulnerable to cyberthreats, online fraud and a system that can be shut down.



Consumer Protection:

Bitcoin does not provide any consumer protection. A perfect transaction cannot be undone. All that remains after a failed transaction is to try to convince the recipient of funds to return them voluntarily. This is due to the fact that there is no intermediary guarantor, as is the case with bank cards. Bitcoin transactions are similar to regular cash transactions, in which there are only 2 parties. The irreversibility of transactions in itself has little effect on the risks of investing in Bitcoin as an asset. However, investors must also be aware of this fact.



Market risk

is the risk that the price of CFD on Bitcoin comprising the Portfolio OYS Bitcoin CFD (¾) will decline. Markets tend to move in cycles, with periods of rising and falling prices.



Little Or No Regulation

currently, the cryptocurrency market is operating without any major regulation. The government doesn't have a clear stance on cryptocurrency.



The Risk of Using Leverage

which is high risk because it supposedly magnifies the potential profit or losses that a trade can bring.
